### **A. West Health Gubernatorial Candidate Engagement**

Commissioner Downey reported the West Health California poll to be released on March 12<sup>th</sup>. He was confidentially briefed on the poll (stratified poll of 1000 people; 3.1% margin of error). Supermajorities think state doesn't do enough for older adults. Results will be useful when talking to elected officials to demonstrate the benefits of supporting aging issues. West Health and Perry Communications believe the Commission's involvement is meaningful. The SCAN Foundation is part of the effort. There will be a public information campaign.

### **B. Hollywood Takes on Aging Roundtable**

Fitzpatrick previewed the Roundtable presenters. The goal is more authentic representation of older adults, additionally the opportunities for partnering with USC's Inclusion Initiative and the Milken Center for the Future of Aging. Fitzpatrick reported on anticipated attendance.

### **C. Reframing Aging Activities**

Fitzpatrick noted the Commission's plan to have the Executive Committee follow this issue for the remainder of the year. The Hollywood Takes on Aging Roundtable is completed. Commissioner Walsh noted that Laura Trejo's Purposeful Aging initiative presentation and the Aging Into the Future conference event should be added to the activity list.
