VI. Public Comment for items not on the agenda

Brenda Anderson commented on the issue of realty companies building unlicensed housing for the elderly and the need to have monitoring and regulation.

VII. Chair's Comments

Chair Walsh announced the resignation of Commissioner Randall and the absence of Commissioner Reyes due to a death in the family. He circulated information about the Desert Aids Project, which the Commission will visit during the November meeting.

VIII. Legislative Advocacy Committee Report (Commissioner Kang/Sewell)

A. Budget Requests Update

Commissioner Kang gave a status report on the budget requests supported by the Commission, which included: **Home Safe homeless prevention grant program** (\$15 million), **Long-term Services & Supports Workgroup: data collection** (\$3 million), **C4A -- Congregate nutrition funding** (\$17.5 million), **Alzheimer's Association – Public Awareness Campaign** (\$2.2 million), **LTC Ombudsman Association** – (\$7.3 million ongoing funding), and **MSSP – rate stabilization** (\$4.7 million).

IX. Executive Committee Report

Commissioner Walsh provided the Executive Committee report.

A. April 3, 2018 Meeting

- **Ratify actions taken by Legislative Advocacy Committee**
Executive Committee ratified the Legislative Advocacy Committee's recommendations.

B. May 3, 2018 Meeting

- **Hollywood Takes: On Aging**

The Executive Committee acknowledged Commissioner Greenbaum's success with the Hollywood Takes On Aging initiative and agreed the Commission's role in the initiative was complete. The Committee encouraged Commissioner Greenbaum to independently continue work on follow-up activities.

C. May 23, 2018

• **Older Californians Act**

Executive Committee learned of possible C4A proposal to update the Older Californians Act and the possibility of CCoA reviewing the Commission's statutes at that time. The topic will be discussed in more detail at the August meeting.

X. Operational Procedures and Bylaws Committee Report

Commissioner Butler thanked Commissioner Anguera for his work on the Reframing Aging presentation and announced that a version would be made available for Commission members to use in their own presentations. The Committee will consider Bylaws changes on its next agenda.

XI. Elder Justice Committee Report

Commissioner Schuldberg and Sewell provided the Elder Justice Committee report.

A. APS Workforce Development Report; co-authorship request

CCoA was invited to co-author an Adult Protective Services (APS) Workforce Development Report being prepared by the APS Liaison at CDSS. The report will be used to support a 2019-2020 budget request for increased APS training funds. The Committee recommended the CCoA accept the request to co-author the report.

Sewell provided an update on conversations with representatives from Ventura, Santa Barbara and San Luis Obispo regarding possible reintroduction of the Victim Compensation Pilot legislation.

XII. Staff Report

Fitzpatrick provided the staff report.

A. Senior Rally

Fitzpatrick reported on a successful Senior Rally.

B. Commissioner Transition

Fitzpatrick reviewed the number of Commissioner terms ending in the coming months and efforts to fill current vacancies.

C. Excess Lodging Form for August Meeting

Villanueva handed out Excess Lodging forms for the August Commission meeting and requested they be signed and returned by the end of the meeting. Fitzpatrick provided a brief review of the August meeting.

D. TEC Deadline

The deadline to submit TEC's for fiscal year 2017-18 is May 31st. Per CDA accounting, TEC's submitted after the deadline may not be processed until July.

E. California Family Caregiver Task Force

Fitzpatrick reviewed the Family Caregiver Task Force infographic that was included in the Commissioner mailing packets.

F. Activity Report

Fitzpatrick reviewed the staff activity report and logistics for tomorrow's meeting.

Fitzpatrick also announced her plan to retire in December and her intention to do as much as possible to leave systems in place for an easier transition. Commissioner Walsh acknowledged Fitzpatrick's role in forming a close collaborative relationship with the Department of Aging.

XIV. Federal Policy Committee Report

Commissioner Petty provided the Federal Policy Committee report.

A. Information Items

- **CCoA “sign on” to opposition letter to House Resolution 2 – 2018 Farm Bill**

Commissioner Petty noted that the Farm Bill was defeated. Expect the bill to be reintroduced sometime soon.

- **NCOA Federal Funding Analysis**

Commissioner Petty commented on the NCOA funding summary in meeting packets.

- **Republican Plan re: Family Leave**

Commissioner Petty commented on the Republican family leave plan, which would impact Social Security funds, resulting in a weakened Social Security trust fund and a diversion away from the historically-stated mission of the program.

- **N4A Key Aging Principles**

N4A’s five Aging Principles were included for information only.

B. Save the Community Transitions Program

Committee recommended that CCoA be prepared to respond to the Legislative Conference Committee action to allocate the full requested amount (19 million) and a minimum of 8 million.

C. Medical Expense Deduction

Commissioner Petty shared the AARP fact sheet on Medical Deductions under the new tax bill, which makes it harder to claim the deduction. The Committee recommends adopting AARP’s proposal that the deduction cut-off point be dropped from 10% back to 7%.

XVII. Presentation: Long-Term Services and Supports (LTSS) Exploratory Coalition

Presenter: Susan DeMarois, State Public Policy Director, Alzheimer's Association

Ms. DeMarois reported on the work of the LTSS Exploratory Coalition, in which labor groups are working with providers, aging and disability community representatives all together to address the state's future LTSS needs.

XVIII. Presentation: West Health National and State Polling Results & *We Stand With Seniors* Campaign

Presenters: Bill Earley, Chief Administration Officer and General Counsel, West Health and Kassy Perry, President and CEO, Perry Communications Group

Mr. Earley provided an overview of the West Health National and State polling results and the *We Stand With Seniors* campaign and outreach to the gubernatorial candidates. The campaign is an educational effort sponsored by West Health and The SCAN Foundation to encourage California's elected leaders and candidates for office to focus on the needs of seniors and implement policies that will improve the lives of all Californians.

XIX. Preview of August Meeting

Fitzpatrick provided information about August meeting plans.

XX. Commissioner Comments

Commissioners commented on meeting items. Commissioner Petty suggested the Choose Medicare Act is something the Commission should keep on their radar. Chair Walsh urged Commissioners to take unexpected opportunities to ask candidates about their views on aging issues.
