VII. **Chair's Comments**

Chair Walsh welcomed Commissioners, presenters and guests to Palm Springs.

A. Introduction of Gretchen Zeagler

Chair Walsh introduced new CCoA Executive Director Gretchen Zeagler. Commissioner Downey reviewed search committee process and Gretchen's background. Zeagler thanked Commissioners.

B. Recognition of outgoing Commissioner Paul Downey

Chair Walsh recognized Commissioner Downey who has served for the past six years and is attending his last meeting. Commissioner Downey expressed appreciation to the Assembly Speaker for allowing him to stay on through the Search Committee process and to staff.

VIII. **Welcome to Riverside County**

Gloria Sanchez, President, Triple-A Council of California (TACC)

Ms. Sanchez welcomed Commissioners to Riverside County on behalf of TACC and reviewed the organization's function.

IX. **Presentation: Health Assessment and Research for Communities (HARC): Senior Report**

Presenter: Jenna LeComte-Hinley, PhD, Chief Executive Officer, HARC

Commissioner Walsh introduced Ms. LeComte-Hinley. LeComte-Hinley reviewed HARC's goal of promoting community health, well-being and quality of life in the Coachella Valley through data collection, research and evaluation. Data enables community to focus on areas of greatest need.

• **Gary Robbins, Deputy Director Office on Aging, County of Riverside**

Mr. Robbins described his agency's programs on Caregiving and Food Insecurity. Caregiving programs include IHSS, Family Caregiver Support Program, Care Pathways, respite care, among others.

• **Hermia Parks, RN, PHN, MA, Director, Public Health Nursing Riverside University Health System - Public Health**

Ms. Parks discussed the history of the Practice Change Fellows Program, which trains teams of health care workers in chronic disease management through the Healthier Living Program for Seniors (HELPS) and the Healthy Options Program.

• **Daniel Parker, PhD, Clinical Psychologist, Desert AIDS Project**

Dr. Parker reviewed the work of Desert AIDS Project's 10 primary care HIV specialty clinics, offering a wellness program and back to work program through case management. Desert AIDS Project is committed to working with HARC, the Office on Aging, and others.

XVI. **Welcome – Commissioner Walsh**
Commissioner Walsh welcomed everyone - thanked Mizell Senior Center for hosting the day's meeting.

XVII. **Opening Remarks by Assembly Member Eduardo Garcia**
Presenter: **Special Assistant and Senior Advisor Steve Brown on Assembly Member Garcia's behalf.**
Commissioner Walsh acknowledged Assembly Member Garcia's legislation establishing the first LGBT Veterans Memorial (SB 2439) in the nation. Mr. Brown reviewed Assembly Member Garcia's legislative record and presented a resolution to the Commission from the Assembly member.

XVIII. **Greetings from David A. Ishida, Regional Administrator, U.S. Administration for Community Living**

Mr. Ishida provided an overview of the Administration for Community Living (ACL) and thanked the CCoA for its achievements and contributions to the aging services network.

XIX. How Federal Policy Shifts & Current Trends are impacting LGBTQ Elders Presenter: Michael Adams, Chief Executive Officer, Services and Advocacy for Gay, Lesbian, Bisexual and Transgender Elders (SAGE)

Mr. Adams focused on how current federal policies threaten LGBT rights and service equity

Policy threats include efforts to eliminate LGBT data collection, discrimination against LGBT individuals on religious grounds, among other things. SAGE is committed to strong LGBT protections in the Older Americans Act and working with Congress to address LGBT needs through the Equality Act and other federal legislation.

Responders:

- **Ron deHarte, Chair, City of Palm Springs Human Rights Commission and President, Palm Springs Pride**

Mr. deHarte was unable to attend.

- **Jill Gover, PhD, Clinical Director, Scott Hines Mental Health Clinic, LGBT Community Center of the Desert (SAGE Affiliate)**

Ms. Gover addressed the impacts of high stress levels on older adults with already weakened immune systems and other chronic conditions and noted increased stress following the 2016 elections, with the community feeling less certain of their rights and protections. Her program focuses on self-care to reduce stress and emphasizing the importance of community and social supports.

- **Jack Newby, Executive Director, The Joslyn Center and former Member Palm Springs Human Rights Commission**

Mr. Newby emphasized the need to compromise in social interactions due to the shifting political climate, saying it is important to keep lines of communication open with friends, family and elected officials.

- **Ginny Foat, Executive Director, Mizell Senior Center and former Palm Springs City Council member**

Ms. Foat described Mizell Senior Center programming and attendance, noting greater acceptance and welcoming of LGBT seniors from the straight attendees. The cultural shift has created more diverse programming and more diverse staffing to make sure all segments of the community are served.

A. Status Update on Positioned Bills

46 of the bills CCoA tracked were signed. Summaries of the legislation are in Commissioners' meeting packets.

XXIII. Federal Advocacy Committee Report

Commissioner Petty reported the committee had reviewed the federal proposal to change the public charge definition and the harmful consequences. The Committee followed three Medicare bills in 2018; only HR 6617, the Choose Medicare Act, moved to the subcommittee on health. No action on the other two bills.

XXIV. Elder Justice Committee Report

Commissioner Schuldberg reported the Committee reviewed California Department of Social Services receipt of federal funds to implement and coordinate improvements to Adult Protective Services (APS) programs as well as to develop a small pilot to give stipends to social work students working with older adults. CCoA was asked to co-sponsor County Welfare Director's Association's new APS budget request.

C. Home Safe Program Update

CCoA co-sponsored the Home Safe Grant program to give 15 counties \$1 million each to develop approaches to preventing elder homelessness. Request for Proposals has been released.

D. Workforce Informational Hearing, Assembly Committee on Jobs and the

Economy, January 2019 (Tentative)

Discussion about legislative hearing underway, but no details are available.

XXVI. **New Business**

A. Caregiver Task Force Strategic Planning Session

Commissioners Brown and Saenz reported on the Caregiver Task Force Strategic Planning Session. Meeting focused on direct action based on the Task Force's seven recommendations; prioritized three, including a legislative resolution focused on caregiver respite, increased funding for the Caregiver Resource Centers, and paid family leave expansion.
