Mr. Petersen noted his work with A Minor Consideration for child actors; now focus areas are retirement; aging issues.

Presenters:

Katherine Pieper, PhD, Research Scientist, USC Annenberg Inclusive Initiative Dr. Pieper presented results of the Annenberg Inclusion Initiative which reviewed the prevalence of age, race, ethnicity of characters in television roles, as well as ageist dialogue and interaction between characters.

George Shannon, PhD, USC Professor of Gerontology and former television and film actor

Professor Shannon discussed his work to show some of the people who are discriminated against and shared a video from a project on discrimination called Dorvador (storytelling) – sponsored by Jewish Community Foundation.

Kate Folb, Director, Hollywood, Health & Society, USC Annenberg Norman

Lear Center, shared the Center's work on full range of shows to make stories as credible as possible. Goal is to get producers and writers to re-think characters and to share good role models.

Arielle Burstein, Associate Director, Center for the Future of Aging, Milken Institute

Provided an overview of the Center's focus on healthy aging, regional economics and the business of aging, which is the economic and human capitol benefit of aging. The work supports the premise that positive self-perceptions extends life and good health, and that a sense of purpose and meaning is preventive against Alzheimer's.
