El Dorado County staff described Mental Health Services Act "Senior Link" project, to coordinate older adult services, transportation, and health care providers for county residents. # XII. Presentation: An Introduction to the Family Caregiver Institute at UC Davis, Betty Irene Moore, School of Nursing

**Presenter: Janice Bell,** MN, MPH, PhD, Associate Dean for Research, Associate Professor, Betty Irene Moore School of Nursing at UC Davis and **Kathryn Sexson**, Ph.D. A.P.R.N., F.N.P. B.C. Assistant Clinical Professor in the Family Caregiving Institute

Ms. Bell reviewed the history of the UC Davis School of Nursing and the role of its Family Caregiver Institute in supporting family caregivers. The school is researching the changing needs of caregivers, use of technology and caregiver navigation along with caregiver and health professional education.

# XIII. Presentation: Elder and Dependent Adult Abuse Project (EDAAP) in El Dorado County

## Presenters:

• Laura Walny, Program Manager, APS, IHSS, and EDAAP, described the El Dorado EADAP project funded through a CalOES Victim Assistance grant. The project pairs APS workers with victim advocates to help elder/dependent adult abuse victims recover and obtain services. Project also partners with Meals on Wheels, Senior Legal Services and other senior programs to provide services, distribute materials.

- **Trudy Kilian**, Staff Services Analyst II, EDAAP and IHSS, reviewed the challenges involved in assessing the eligibility of victims served through the grant, reporting that the target number to be served was surpassed.
- **Michelle Ward**, Senior Legal Attorney with El Dorado Legal Services, Senior Legal Service's primary goal is elder abuse prevention through the work of estate planning, advance healthcare directives and Power of Attorney designation to protect an elder's resources, along with work to prevent evictions and other cases.
- **David Groth**, District Attorney's Office Victim Witness Specialist Liaison, works with the District Attorney on behalf of victims to help with court procedures and Victim Compensation applications.
