#### XI. Federal Policy Committee Report

#### A. Mid Term Election Projection

The Committee reviewed the National Council on Aging (NCOA) blog discussing potential risks for Older Americans Act program funding without a budget agreement from Congress.

#### B. Community Transitions Program Update

Money Follows the Person funding was continued through a short-term funding bill to provide three months funding until a permanent budget is approved. The Older Americans Act is up for reauthorization in 2019. There will be informational hearings in the state that we will monitor. NCOA working to reinstate the House Special Committee on Aging in partnership with the Leadership Council of Aging Organizations. The Committee discussed impacts of the federal government shut-down on older adult programs, including Section 202 housing for the elderly, Community Development Block Grants, and SNAP.

### C. Request for Information on Modifying HIPAA Rules to Improve Coordinated Care HHS-OCR-0945 AA00

The Committee reviewed an Administration for Community Living (ACL) proposal for covered entities to share protected information to address the opioid crisis. Commissioner Walsh said comment period ends 2/12 - encouraged local comments on the issue.

### XII. Elder Justice and Caregiving Committee Report

Commissioner Conger provided the Elder Justice and Caregiving Committee report.

### A. Adult Protective Services Training Budget Request

The Committee recommended that CCoA co-sponsor the County Welfare Directors Association (CWDA) request for \$5.75 million for the Adult Protective Services (APS) training budget.
