Kuroda provided the Executive Director's report. The CCoA Bylaws and Standing Rules were reviewed and updated by CDA's attorney. Kuroda noted plans for the Elder Abuse Awareness Month event featuring Kathy Greenlee as keynote speaker.

Chair Butler reviewed search committee timeline; edits on job description and SOQ to be completed today; May 8<sup>th</sup> to June 7<sup>th</sup> is the application period; June 12<sup>th</sup> review; July 8<sup>th</sup> and July 22<sup>nd</sup> interviews; looking to hire by the end of August.

Chair Butler reported the Master Plan letter will be released tomorrow to relevant committees and to leadership. Goal is to release the letter by early next week at the latest.

Chair Butler announced plans for the San Francisco meeting in September were not working out. Staff is looking at San Jose, Sacramento or Napa as alternate location.
