### 6. Public Comments for items not on the agenda

Karen Gorback thanked the Commission for coming to Thousand Oaks.

### 7. Comments from the Chair

Chair Butler shared her hopes for the Governor's Executive Order on the Master Plan on Aging. Chair Butler commented on the recent San Diego KPBS TV series titled "Graying California" which featured Commissioner Butler and former Commissioners Paul Downey and Donna Benton. She expressed appreciation for Kuroda and Fitzpatrick's help administering the Commission.

### 8. Special Guest: Ricardo Lara, California Insurance Commissioner

Insurance Commissioner Lara spoke of his work on insurance fraud, long-term care insurance, and senior scam awareness. He discussed the Department of Insurance's work to increase access to insurance for all, including undocumented older adults. Through his work with the National Association of Long-Term Care Insurers, Lara is involved in efforts to solve the problem of long-term care "legacy policies" that fail to cover policy-holder needs.

### 9. Welcome to Ventura County

Presenter Vanise Terry, aide to Ventura County Supervisor Linda Parks, welcomed CCoA to Ventura County.

# 10. Presentation: Alzheimer's & Related Dementia Presenter: Susan Guffee, Clinical Services Program Manager, Ventura County Area Agency on Aging (AAA)

Ms. Guffee provided an overview of the county-based AAA and the local service delivery network. The county's large 60+ population is expected to increase 14% by 2023. High rates of Alzheimer's disease have prompted a commitment to become a Dementia Friendly county which includes developing a network of dementia-friendly businesses, dementia cafes, a dementia awareness bus, and dementia friendly care management services.

### 11. Presentation: Fall Prevention

Presenter: Dr. Thomas Duncan, Trauma Medical Director, Ventura County Medical Center and Medical Co-Director, Anacapa Surgical Associates, and Monique Nowlin, Deputy Director, Ventura County Area Agency on Aging

Dr. Duncan reviewed the development of fall prevention programming and cited national statistics on fall-related injuries and deaths.

Ms. Nowlin outlined Ventura AAA's fall prevention program goals of reducing preventable falls, raising awareness, establishing baseline data to track number of falls and incidents of repeat falls after mitigation.

### 13. **Presentation: Elder Justice/Family Service Center**

Presenter: Michael Jump, Chief Deputy District Attorney, Ventura County District Attorney's Office

Mr. Jump reviewed the effort behind creation of the Family Justice Center, a "one-stop shop" serving victims of domestic violence, sexual assault, elder and dependent adult abuse, child abuse, and human trafficking. The center works directly with the Area Agency on Aging to provide elder abuse victims with additional services.

### 14. Federal Policy Committee Report

#### a. Older Americans Act Reauthorization

Commissioner Walsh provided an update on the upcoming Older Americans Act reauthorization and concerns with the Senate's draft bill, including funding limitations.

### b. Administration on Community Living Reorganization

Commissioner Walsh reported on the Administration for Community Living and their announcement to relocate most regional office staff except for Administrators to Washington D.C.

Commissioner Walsh reported on the extension through September 30, 2019 of the Money Follows the Person program and the Spousal Impoverishment Rule.

### d. Medicaid Non-Emergency Medical Transportation

Commissioner Walsh reviewed a CMS proposal to make Medicaid coverage for nonemergency medical transportation an optional benefit.

# e. The White House Office of Management and Budget (OMB) proposal to change how the official poverty measure is calculated Commissioner Walsh discussed the technical change proposed by OMB that would count fewer individuals at or below poverty, resulting in lower eligibility levels for government aid. Comments are due by June 21, 2019.
