7. Self-Introductions

Commissioners and guests introduced themselves. Commissioners discussed which of the four top issues areas for CCoA resonated the most. Top four areas include: 1. Older Adult Behavioral Health; 2. Housing and Homelessness; 3. Workforce Development: direct care, Gerontology, Geriatrics, and related fields; 4. Innovative Models: increase access to and coordination of long-term services and supports.

8. Legislative Committee Report: Chair Schmeding

The Legislative Advocacy Committee held a Special Committee meeting on April 13th and took positions on 14 bills. Coleman reviewed the CCoA legislative platform.

- Support for nine funding requests, including \$212,000 for behavioral health leadership position
- Waiting for the release of the Governor's May Revise Budget
- Support 14 bills and following an additional eight policy items
- Coleman provided an update on AB 2619- RCFE: capacity. The Legislative Advocacy Committee recommended that it be pulled by author, rather than die in the Human Services committee.

a. Elder and Disability Justice Coordinating Council

Chair Schmeding shared about CARE Court and the need to enhance programs to reduce the over utilization of conservatorship.

b. Disability and Aging Community Living Advisory Committee (DACLAC) Swartzlander shared the focus of the Disability and Aging Community Living Advisory Committee is on accessible transportation. Debbie Toth and representatives from the California Department of Transportation attended and

followed up by meeting with the DACLAC transportation subcommittee.
