**California Commission on Aging Opposes
use of the Chained CPI**

The California Commission on Aging (CCoA) in April joined with a broad contingent of advocates and service providers asking Congress and the President to oppose a proposal to use a “chained CPI” to formulate cost-of-living adjustments for Social Security and other programs serving the country’s most vulnerable citizens.

In its letter, the CCoA highlighted the fact that use of the chained CPI will have negative financial consequences for millions of elderly, disabled and poor individuals. The effect of this change would be a significant reduction of income for individuals already living on the edge. “A loss of \$130 per year may seem insignificant for a middle-class working family,” the Commission wrote, “but for an elderly retiree relying primarily on their \$1,000 month check, even a small monthly reduction may mean the difference between food and medicine or paying an electric bill.” The letter noted that nearly two-thirds of all older adults rely on Social Security for half of their income, while for 36%, Social Security is 90% of their income.

State Plan on Aging Hearings Set

The California Department of Aging (CDA), in partnership with the CCoA, will hold three public hearings on the draft *California State Plan on Aging – 2013-2017 (State Plan)*. The federal Administration on Aging mandates the *State Plan* as a condition for the State to receive federal Older Americans Act funding. The Department of Aging and CCoA are seeking input from older adults, persons with disabilities, family caregivers, agencies and advocacy groups serving these individuals, and other interested parties. Cal MediConnect Delay Announced

California Department of Health Care Services (DHCS) has announced a delayed start-date of January 2014 for implementation of Cal MediConnect, the shift to managed care Medi-Cal coverage for California's dual-eligible population. Part of the Governor's 2012-2013 budget adjustments, DHCS Director Toby Douglas said "Cal MediConnect represents a historic effort to integrate the medical, social, and mental health services provided to some of the most vulnerable members of society."

The coordination of services provided under the new program will require integration of systems on multiple levels, including government, private health plans, and communities. Along with the systems shift, the Department has made a substantial effort to incorporate stakeholder input throughout the process.
